PENNSYLVANIA, AMENDING THE LIBERTY TOWNSHIP ORDINANCE NO 2, 1999  
PROHIBITING CERTAIN TRAFFIC AND VEHICULAR CONDUCT IN THE  
TOWNSHIP OF LIBERTY, ADAMS COUNTY, PENNSYLVANIA**

**BE IT ENACTED AND ORDAINED** by the Board of Supervisors in and for the Township of Liberty, Adams County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

**SECTION I: ESTABLISHMENT.**


This Ordinance amends and reestablishes Ordinance No 2, 1999 Prohibiting Certain Traffic and Vehicular Conduct in The Township of Liberty, Adams County, Pennsylvania.

TEXT AMENDMENT: Purpose of this change is to amend violations and penalties.


Section I

c) Whoever violates any provisions of this chapter shall, upon conviction thereof in a summary proceeding, be fined for a first offense, not more than \$100.00; for a second offense be fined not less than \$100.00 and not more than \$250.00; for a third offense be fined not less than \$250.00 and not more than \$500.00, to be collected as other fines and costs are by law collectible. Whoever violates any provision in this chapter for a fourth offense and for any subsequent conviction shall, upon conviction thereof in a summary proceeding, be fined \$500.00 to be collected as other fines and costs are by law collectible.

LIBERTY TOWNSHIP ORDINANCE PROHIBITING CERTAIN  
TRAFFIC AND VEHICULAR CONDUCT

ORDINANCE NO. 2, 1999

AN ORDINANCE OF LIBERTY TOWNSHIP PROHIBITING CERTAIN TRAFFIC AND  
VEHICULAR CONDUCT IN THE TOWNSHIP OF LIBERTY, ADAMS COUNTY,  
PENNSYLVANIA

WHEREAS, Liberty Township, Adams County, Pennsylvania finds certain vehicular operation and conduct to be dangerous and unsafe and;

WHEREAS, After a public meeting, the Board of Supervisors of Liberty Township believe it is in the public interest, safety and welfare to prohibit certain vehicular conduct and operations;

NOW, THEREFORE, Liberty Township, Adams County, Pennsylvania hereby enacts and ordains the following:

Section I

Disorderly Operation of a Vehicle

a) It shall be unlawful at all times within this Township, for any person operating or being in physical control of a motor vehicle, to race the engine of the vehicle, spin the tires, or to give a display of acceleration, for no legitimate purposes.

b) It shall be unlawful for any person to operate a motor vehicle in a physically offensive manner, or endanger, or cause annoyance or alarm to the traveling public or residents along any public road or highway within the boundaries of Liberty Township.

c) Any person (s) operator(s), driver(s), corporation or individual(s) who violates subsection a or b shall upon conviction be sentenced to pay a fine of \$100.00 and costs of prosecution.


Section II


Motor Vehicle. A Motor Vehicle is defined for purpose of this Ordinance as a vehicle which is self-propelled except one which is propelled by human power and shall include automobiles, trucks, tractor trailers, limousines, taxi cabs, motor scooters, motorcycles, motorized pedal cycle, recreation vehicles, and passenger cars.
