Regular Scheduled Meeting**

The Board of Supervisors of Liberty Township, of Adams County, met Tuesday, May 1 at 7:30pm at the Liberty Township Municipal Building, 39 Topper Road, Fairfield, PA 17320, for their regular scheduled meeting.

Present: Peter Foscatto Chairman, John Bostek, Bob Jackson, LeeEsta Frishkorn, Matt Harvey and Solicitor Davis.

**Supervisors' Remarks:**

**Minutes** of the *April 3*, 2012 meeting were read and not objected to.

**Treasurer's Report** was accepted by the Supervisors.

**Approval of bills:**

Mr. Jackson made a motion to pay the bills as stated, seconded by Mr. Bostek and passed unanimously.

**Storm water Ordinance-** Solicitor Davis stated the model ordinance does not give the formulas which some townships want included in the ordinance. Mr. Davis asked the board to discuss this with their engineers. **A motion by Mr. Jackson to table the storm water ordinance was seconded by Mr. Foscatto and passed unanimously.**

**MASA Subdivision-** Lee Royer Engineer for MASA is requesting a waiver to have the entire property in compliance with the current storm water ordinance. **A motion to grant the waiver request pending KPI comments was seconded by Mr. Bostek, with Mr. Jackson abstained with the motion passed.**

**Liberty Development Ordinance Plan Scale Waiver-** Mr. Wiley of Liberty Development requests a waiver on the size of the plans. **A motion by Mr. Foscatto to accept the scale waiver was seconded by Mr. Bostek and passed unanimously.**

**Liberty Development Extension Request-** Liberty Development submitted a letter granting the township 172 days to review the plans. **A motion by Mr. Foscatto to accept the 172 day extension was seconded by Mr. Bostek and passed unanimously.**

**Dayhoff Plan Revision-** Ms. Frishkorn stated this plan was originally approved several months ago. It has been revised due to located lost pin on the one corner of the property and has been re-surveyed. **A motion by Mr. Bostek to approve the revised Dayhoff plan was seconded by Mr. Jackson and passed unanimously.**

With no further business, the meeting adjourned at 8:10p.m. on a motion by Mr. Bostek, seconded by Mr. Jackson. Vote unanimous.
