***Regular Monthly Meeting
April 5, 2011***

The Board of Supervisors of Liberty Township, Adams County, met Tuesday, *April 5, 2011* at 7:30p.m.at the Liberty Township Municipal Building, 39 Topper Rd, Fairfield, for its regular monthly meeting.

Present: Peter Foscatto Chairman, John Bostek, Mr. Robert Jackson, LeeEsta Frishkorn Secretary, Chief Harvey and Solicitor Davis.

Supervisors' Remarks: None.

Minutes of the March 1, 2011 meeting were read and approved.

Revised Minutes of the February 22, 2011 meeting were approved

Treasurer's Report was accepted by the Supervisors.

Approval of bills:

Mr. Jackson made a motion to pay the bills as stated, seconded by Mr. Bostek and passed unanimously.

Public Participation: Jim Martin, Candidate for Adams County Commissioner gave a brief statement.

Solicitor – None.

Police Officer's Report – Chief Harvey read his report, no comments.

Zoning Officer's Report – Mr. Bostek read this report, no comments.

Roadmaster Report- Mr. Jackson read this report and stated Mr. Arentz repaired a washout on Gladhill Road, cut brush and cleared side gutters and worked on road signs. Washed trucks and the backhoe, fixed a sign on Boyle Road and removed a tree on Stoops Road.

Planning Commission Report – Mrs. Wenchhof stated the commission tabled the Deeds subdivision and reviewed a sketch plan.

Old Business:

American Odyssey Race- Chief Harvey stated the organizer for the race changed the route for the runners with no changes with in Liberty Township. The race will be held on April 29, 2011 and will utilize McGlaughlin, Liberty Hall, Tract, and Sanders Roads. **A motion, allowing the runners to use Township Roads was made by Mr. Bostek and seconded by Mr. Jackson and passed unanimously.**

New Business:

AE-AD Lots- Adams County Tax Claim Bureau is requesting to combine certain lots to be offered for tax sale. Mr. Davis stated this may be needed just to sell the lots but any buyer must still conform to the current ordinances for their use. **A motion to allow the Tax Claim Bureau to combine lots in AE-AD section by Mr. Bostek was second by Mr. Jackson and passed unanimously.**

Updating Inter-Municipal Agreement on Workers Compensation Plan- Ms. Frishkorn stated Hamiltonban Township would like to setup a meeting to update the current agreement. **A motion by Mr. Jackson for Ms. Frishkorn to schedule the Workers Comp Plan with Hamiltonban Township was seconded by Mr. Bostek and passed unanimously.**

Liquid Fuels Deposit- Ms. Frishkorn stated we have received the annual liquid fuels reimbursement in the amount of \$50,422.83.

Mr. Jackson stated the 23 of April will be the 150 Anniversary of the Battle of Fairfield. Events will take place on Saturday and Sunday thru out the day.

Mr. Sam Ginn of Fountaindale Fire Company read his report on calls with in the Township.

With no further business, the meeting adjourned at 8:01 p.m. on a motion by Mr. Jackson, seconded by Mr. Bostek. Vote unanimous.
